We are taking this opportunity to thank Selma Moidel Smith, not only for her "Cumulative 21-Year Index for *Experience*" and the many articles she has written for Senior Lawyers Division ("SLD") publications, but also for her years of loyal support of this Division.

Selma's first Index for Experience was a surprise gift to the Senior Lawyers Division given upon completion of her service as chair of the Editorial Board in 2001. During her term, she made significant innovations for the benefit of both the magazine and the Board. She redirected members of the Editorial Board into active roles soliciting, occasionally writing, and reviewing the content of articles, making it possible to fill all pages for each issue with quality, relevant material. Among the articles she wrote was "The First Women Members of the ABA," which was based on her extensive original research. She solicited many authors for Experience, including the first international author. She created an "Our Authors" page for this magazine and increased the use of color and photographs. In April 2001, she arranged for the first posting of *Experience* articles on the SLD website. Selma seems always to have been ahead of the technology curve.

Selma came to the SLD in 1996 when Chair Victor Futter asked the National Association of Women Lawyers ("NAWL") to send a liaison to the SLD. What a gift we got in Selma! She has been an inspiration to me and many other women lawyers. After being elected to the SLD Council in 1997, she composed a "Dear Sister-in-Law" letter that was highly successful in recruiting new women members. Following her service to this magazine, Selma went on to chair our newsletter, *Voice of Experience*, from 2003–05.

We are not the only ones to pay tribute to Selma. NAWL presented Selma its Lifetime of Service Award in 1999 and created the annual Selma Moidel Smith Law Student Writing Competition.

So we dedicate this issue to a woman who has given so much to our Division. She is a remarkable person, author, composer of more than 100 piano and orchestral pieces, and dear friend to so many members of this Division.

Turning now to the lead article in this issue, author Charles Sabatino, director of the ABA Commission on Law and Aging, is sure to give us all a new focus on issues for the elderly that extend beyond our borders. Mr. Sabatino presents us with an article on international efforts to protect aging people around the world. By 2050, people over the age of 60 will make up 22 percent of the world's population. You will learn of United Nations activities and resolutions that have begun to "recognize the need for consideration of an international instrument addressing the rights of older persons." This is an effort we will follow in the future.
